Responsible for the management of all Production Sharing Contracts and Production Individualization Agreements entered into in the so-called Pre-Salt Polygon, with the objective of contributing to the maximization of the economic result for the Union.

Preliminary results already include the production of the FPSO Libra Pioneer and the construction of the FPSO Guanabara for Mero-1.

In the period I worked in the area, we undertook an in-depth optimization of the structure and began the operations of the Route 2 pipeline and the maritime activities of the Route 3 pipeline, both of the Pre-Salt. It was also proposed to stop the work of UFN's 3 and 5 due to the contractual problems faced and gas supply difficulties.

Responsible for Petrobras' upstream and downstream activities, which were locally executed by PAI - Petrobras America, POG - Petrobras Oil and Gas (JV with Banco Pactual) and Pasadena Refineries (USA) and Nansei (Okinawa) I reported to the International Director, working with 3 General Managers in Brazil and also with the Presidents of the aforementioned companies. I used to participate on the Board of PAI and, informally, on the Board of POG. At that time we achieved the production record in Cascade and Chinook, the POG partnership was consolidated and units in Africa were reorganized or closed, such as Portugal, Libya, Tanzania, Benin and Angola. We also proposed to the Board to terminate Nansei Refinery activities due to poor economic results, which in fact occurred later.

Responsible for the interface between E&P and Engineering relating to the works for the implementation of the production development projects. Several FPSOs were under construction for E&P, including Replicant and Onerous Transfer Agreement FPSOs. In PGSU I was also responsible for the specification of the rigs of Sete Brasil. I reported to the E&P Director and worked with 4 General Managers. In the period I worked in the area, units P-58, P-61, P-63 and TAD were delivered.
